USE OF TOWNSHIP FACILITIES AND GROUNDS

Use of Township facilities and grounds may be requested by making written application to Ephrata Township for fields and pavilions. In considering such applications, Ephrata Township functions and schedules shall have priority. Due to limitations in the amount of parking, pavilion usage will be limited to events for a maximum of 100 people. All reservations must be submitted to the Township no later than 14 days prior to the date of the event.

Anyone requesting the use of Township facilities will be classified in one of the following three Applicant categories by administration, and subject to appropriate fee schedules and costs (attached). Such fee schedule and costs have been established by Resolution by the Board of Supervisors and made part of this policy.

CLASS A	All organizations affiliated with or supervised by Ephrata Township; or as determined by the Board of Supervisors.
CLASS B	Ephrata Township Residents and Businesses; Ephrata Township Non-profit

Ephrata Township Residents and Businesses; Ephrata Township Non-profit organizations (Civic, Fraternal, Religious, Educational).

CLASS C All others.

- * DRUGS AND ALCOHOL ARE PROHIBITED on Township property at all times.
- * **SUNDAY USE** No Sunday use before 12:00 P.M. without prior approval.

ALL FACILITIES AND GROUNDS

The Township reserves the right to restrict and/or cancel any approved use at any time.

The Township may require a refundable deposit, from which damages and clean-up may be recovered.

Out-of-pocket costs will be assessed to the Applicant.

All applicants granted use of Ephrata Township facilities are expected to exercise care in protecting Township property from damage. All damages will be the responsibility of the Applicant. The Applicant shall supervise activities to prevent disorderly conduct at any time while using Township facilities. Only appropriate uses will be permitted. The Applicant shall be responsible for any special needs. No safety violations are permitted.

Failure to conform to the above conditions, and those set forth in the rental agreement, or to adhere to the Ephrata Township Park Rules and Regulations, will cause Ephrata Township officials to immediately terminate use of the facilities and to deny such use to the Applicant in the future.
